COVID-19 drove an acceleration in demand for sweet spreads packaging during 2020. Increased consumption of sweet spreads was mainly driven by the fact that consumers spent more time at home during the year and ate more there. Sweet spreads on bread is popular as a quick snack among local consumers. However, as restrictions were eased and a semblance of normalisation returned to society in Hong Kong, all but honey went into decline in 2021.
