Sweet spreads recorded a slowdown in the rate of growth in the volume of packaging units used in this category in 2020. There was some stockpiling of sweet spreads during the early stages of the pandemic, but this was not widespread and proved to be short lived. While the fact that consumers spent more time at home during 2020 due to restrictions on movement helped to support demand for sweet spreads packaging, this was more than offset by the economic shock of COVID-19, which forced many consum...
