The rate of growth in the use of total packaging units in sweet spreads doubled during 2020, reaching its highest level in the review period. This was a result of consumers spending more time at home during the year due to COVID-19 and therefore eating more meals and snacks there. In particular, many had more time to eat breakfast at home, boosting demand for jams and preserves, nut- and seed-based spreads, chocolate spreads and honey. While growth then slowed in 2021, it still remained roughly...
