KEY FINDINGS

The India medical grade paper market is set to grow with a CAGR of 5.62% during the estimated period of 2030. While the base year for the studied market is 2022, the forecasted years are from 2023 to 2030. Key factors augmenting the regional market's growth include the surging demand for high-quality medical devices as well as healthcare services, the rapidly-developing pharmaceutical industry, and the increase in medical tourism.

MARKET INSIGHTS

The demand for pharmaceutical packaging is especially high in highly populated countries, including India. Aligning with this, as per the Indian Economic Survey 2021, the country's domestic pharmaceutical business was valued at \$42 billion in 2021, expected to augment to \$65 billion by 2024 as well as \$120-130 billion by the year 2030. Furthermore, medical and pharmaceutical exports in India equated to \$24.44 billion in 2021.

On the other hand, the medical device industry in India is dominated by international corporations, in addition to relatively fewer domestic firms. Since regional companies are expected to foresee transitioning market dynamics, they are also focusing on low-cost as well as affordable medical gadgets. In this regard, several foreign corporations have entered the Indian market by purchasing local medical device firms, while utilizing them as a counter-strategy against domestic competitors. Therefore, these factors are projected to accelerate the medical grade paper market growth in India during the estimated years.
