- The ice cream market consists of artisanal ice cream (both dairy and water-based), impulse ice cream (includes single-serve ice cream tubs, packaged cones ice cream sandwiches, and chocolate-coated ice creams) and take-home ice cream (includes multiple-serving ice cream tubs and, ice-cream cakes). The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2021 exchange rates.
- The Canadian Ice Cream market had total revenues of \$754.1m in 2021, representing a compound annual growth rate (CAGR) of 2.3% between 2016 and 2021.
- Market production volume increased with a CAGR of 2% between 2016 and 2021, to reach a total of 146.9 million kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.9% for the five-year period 2021 2026, which is expected to drive the market to a value of \$871.4m by the end of 2026.
