- The Chinese Household Products market had total revenues of \$43,342.1m in 2021, representing a compound annual growth rate (CAGR) of 10.4% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 6.7% between 2016 and 2021, to reach a total of 16,997.1 million units in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 6.3% for the five-year period 2021 2026, which is expected to drive the market to a value of \$58,813.0m by the end of 2026.
