The lip make-up segment consists of lip liner, lipstick, lip gloss and other lip make-up products. The nail make-up segment consists of nail polish. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2021 exchange rates.
- The South Korean make-up market had total revenues of \$1,887.3m in 2021, representing a compound annual growth rate (CAGR) of 5.7% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 5% between 2016 and 2021, to reach a total of 104.3 million units in 2021.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 5.6% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$2,473.4m by the end of 2026.
