- Market consumption volume increased with a CAGR of 0.9% between 2016 and 2021, to reach a total of 62.6 million units in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.5% for the five-year period 2021 2026, which is expected to drive the market to a value of \$3,723.3m by the end of 2026.
