The gum segment consists of all bubble and chewing gum. Moreover, the sugar confectionery products consists of hard boiled sweets, mints, caramels & toffees, gums and jellies, marshmallows, fudges and medicated throat lozenges. The market is valued according to retail selling price (RSP) and includes any applicable taxes. Any currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Italian Confectionery market had total revenues of \$5,635.9m in 2021, representing a compound annual growth rate (CAGR) of 1.1% between 2016 and 2021.
- Market production volume increased with a CAGR of 0.2% between 2016 and 2021, to reach a total of 315.1 million kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 1.8% for the five-year period 2021 2026, which is expected to drive the market to a value of \$6,163.8m by the end of 2026.
