- The cloud computing industry consists of the Infrastructure as a Service (IaaS), Platform as a Service (PaaS) and Software as a Service (SaaS) segments. Values are calculated based on revenues accrued from these services. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The European cloud computing industry had total revenues of \$84.8 billion in 2021, representing a compound annual growth rate (CAGR) of 22.8% between 2016 and 2021.
- The SaaS segment accounted for the largest proportion of the industry in 2021, with total revenues of \$52.3 billion, equivalent to 61.6% of the industry's overall value.
- Germany overtook the UK as the leading country in the European industry, accounting for 18.6% of its total value in 2019. In 2021, the country accounted for a 20.3% share of the European cloud computing industry.
