The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2021 exchange rates.
- The North American make-up market had total revenues of \$15,118.6m in 2021, representing a compound annual growth rate (CAGR) of 0.2% between 2016 and 2021.
- Market consumption volumes declined with a CAGR of -2.2% between 2016 and 2021, to reach a total of 2,147.3 million units in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4% for the five-year period 2021 2026, which is expected to drive the market to a value of \$18,401.2m by the end of 2026.
