All market data and forecasts are represented as a consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The South American games software market had total revenues of \$1.1 billion in 2021, representing a compound annual growth rate (CAGR) of 8.0% between 2016 and 2021.
- The market has kept expanding in recent years, mainly driven by the uptake of video game consoles and internet connections.
- The value of the South American games software market grew by 10.1% in 2021.
