The consumption of shelf stable meat and seafood was bolstered in 2020 by the onset of the pandemic due to stockpiling, and because of the long shelf life of these products compared with fresh meat and seafood. In addition, the closure of foodservice outlets meant that people had to cook at home, moving sales from foodservice to retail. As such, packaging volumes of the metal food cans exclusively used in these categories rose over 2019-2020. This continued, although to a lesser extent, over 202...
