All market data and forecasts are represented as consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The South African toys & games retail market had total sales of \$276.5 million in 2021, representing a compound annual growth rate (CAGR) of 8.4% between 2017 and 2021.
- Other specialist retail account for the largest proportion of sales in the South African toys & games retail market in 2021. Sales through this channel generated \$193.4 million, equivalent to 69.9% of the market's overall value.
- The growth of the South African toy industry can be attributed to a variety of factors, including parents' growing interest in eco-friendly toys, the resurgence of traditional toys, and knowledge of the cognitive advantages of building toys.
