- The South African haircare market had total revenues of \$495.4m in 2021, representing a compound annual growth rate (CAGR) of 4.6% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1.1% between 2016 and 2021, to reach a total of 126.1 million units in 2021.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 4.7% for the five-year period 2021 2026, which is expected to drive the market to a value of \$623.1m by the end of 2026.
