- The South African jewelry & watches market generated total revenues of \$1,296.3 million in 2021, representing a compound annual growth rate (CAGR) of 3.3% between 2017 and 2021.
- The jewelry & watches segment was the market's most lucrative in 2021, with total revenues of \$794.3 million, equivalent to 61.3% of the market's overall value.
- In 2020, the market declined due to COVID-19 pandemic lockdown restrictions and economic downturn. However, in 2021, the market rebound to pre-pandemic level owing to economic recovery and increased consumer spending.
