- The Canadian haircare market had total revenues of \$1,287.2m in 2021, representing a compound annual growth rate (CAGR) of 2.2% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 0.9% between 2016 and 2021, to reach a total of 126.9 million units in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 1.9% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$1,414.3m by the end of 2026.
