- The Chinese jewelry & watches market generated total revenues of \$159,199.0 million in 2021, representing a compound annual growth rate (CAGR) of 2.3% between 2017 and 2021.
- The jewelry & watches segment was the market's most lucrative in 2021, with total revenues of \$93,986.9 million, equivalent to 59% of the market's overall value.
- In 2020, the market experienced negative growth owing economic uncertainty, low demand, and diverted spending on essential goods. However, in 2021, the market surge to strong growth owing to economic recovery, relatively stable gold price, and pent-up wedding gold jewelry demand from 2020.
