All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The Indian beer & cider market had total revenues of \$8,240.5m in 2021, representing a compound annual growth rate (CAGR) of 5.7% between 2016 and 2021.
- Market consumption volumes declined with a CAGR of -2.1% between 2016 and 2021, to reach a total of 2,160.7 million liters in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 16.4% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$17,625.6m by the end of 2026.
