- The toys & games market includes retail sales of action figures, activity toys, dolls, games, infant and baby toys, miniature models, plush toys, puzzles, ride-on model toys, and toy vehicles. All market data and forecasts are represented as consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Indonesian toys & games retail market had total sales of \$1,694.8 million in 2021, representing a compound annual growth rate (CAGR) of 4.7% between 2017 and 2021.
- Other specialist retailers account for the largest proportion of sales in the Indonesian toys & games retail market in 2021. Sales through this channel generated \$1,296.0 million, equivalent to 76.5% of the market's overall value.
- A growing population, increasing annual wages, and an expanding middle class has encouraged consumption in Indonesia, which in turn has driven growth in the toys and games market.
