All market data and forecasts are represented as a consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Japanese apparel retail industry had total revenues of \$77.3 billion in 2021, representing a compound annual rate of change (CARC) of -2.8% between 2017 and 2021.
- Clothing, footwear, and accessories specialists account for the largest proportion of sales in the Japanese apparel retail industry in 2021, sales through this channel generated \$29.7 billion, equivalent to 38.5% of the industry's overall value.
- In 2021, the Japanese industry witnessed swift growth as the lockdown measures were lifted and the economy witnessed recovery. According to in house research, Japan's unemployment rate was 2.8% in 2021.
