- The beer & cider market consist of the retail sale of beer and cider. The beer segment consists of ale, dark beer, lager, stout, flavored beer, wheat beer, beer mixes and seasonal beer. The cider segment consists of apple cider, flavored cider, pear cider and seasonal cider. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The Singaporean beer & cider market had total revenues of \$1,208.4m in 2021, representing a compound annual growth rate (CAGR) of 0.7% between 2016 and 2021.
- Market consumption volumes declined with a CAGR of -0.2% between 2016 and 2021, to reach a total of 119.5 million liters in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.4% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$1,496.6m by the end of 2026.
