#### Summary

Toys & Games Retail in Singapore industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). ## **Key Highlights**

- The toys & games market includes retail sales of action figures, activity toys, dolls, games, infant and baby toys, miniature models, plush toys, puzzles, ride-on model toys, and toy vehicles. All market data and forecasts are represented as consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Singaporean toys & games retail market had total sales of \$270.1 million in 2021, representing a compound annual growth rate (CAGR) of 0.4% between 2017 and 2021.
- Other specialist retailers account for the largest proportion of sales in the Singaporean toys & games retail market in 2021. Sales through this channel generated \$107.2 million, equivalent to 39.7% of the market's overall value.
- The growth of the Singaporean toys and games market is set to be strong during the forecast period, mainly driven by the increasing popularity of traditional recreational activities coupled with an increasing preference for games at social events among individuals across the region.
