- The Jewelry, Watches and Accessories market includes gold jewelry, silver jewelry and other precious jewelry like diamonds, platinum, precious stones (sapphires, emeralds and rubies), pearls (natural and cultured) and semi-precious stones (e.g. quartz, opal, topaz, amethyst, coral etc.), fashion jewelry (non-precious jewelry), hair accessories, belts, hats, gloves, scarves, sunglasses and ties, plus watches.
- The Singaporean jewelry & watches market is forecast to generate total revenues of \$3,665.6 million in 2021, representing a compound annual rate of change (CARC) of -1.5% between 2017 and 2021.
- The jewelry & watches segment was the market's most lucrative in 2021, with total revenues of \$3,132.0 million, equivalent to 85.4% of the market's overall value.
- In 2020, the Singaporean jewelry market was one of the worst affected markets in the country, mainly due to decline in tourism receipts. In 2021, owing to the opening of the market and removal of travel restrictions the market surged to double-digit growth.
