- The Australian jewelry & watches market generated total revenues of \$4,937.4 million in 2021, representing a compound annual growth rate (CAGR) of 0.5% between 2017 and 2021.
- The Jewelry & Watches segment was the market's most lucrative in 2021, with total revenues of \$2,845.5 million, equivalent to 57.6% of the market's overall value.
- In 2020, the market experienced declined growth due to stores closure during COVID-19 pandemic. However, the market surged to strong growth in 2021 owing to economic recovery, rising consumer income and spending, and residual demand from 2020.
