- The Russian savory & deli foods market had total revenues of \$6,134.1m in 2021, representing a compound annual growth rate (CAGR) of 3.4% between 2016 and 2021.
- Market consumption volumes declined with a CAGR of -0.4% between 2016 and 2021, to reach a total of 1,422.4 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.1% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$7,149.4m by the end of 2026.
