Summary

Key Highlights

- The apparel retail market includes baby clothing, toddler clothing and casual wear, essentials, formalwear, formalwear-occasion, and outerwear for men, women, boys and girls; excludes sports-specific clothing. All market data and forecasts are represented as a consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Austrian apparel retail industry had total revenues of \$10.0 billion in 2021, representing a compound annual rate of change (CARC) of -1.3% between 2017 and 2021.
- Clothing, footwear, and accessories specialists account for the largest proportion of sales in the Austrian apparel retail industry in 2021, sales through this channel generated \$5.4 billion, equivalent to 54.3% of the industry's overall value.
- In 2021, the Austrian industry witnessed swift growth as the lockdown measures were lifted and the economy witnessed recovery. This is likely to have strengthened consumers' purchasing power, leading to an increase in spending on non-essential items such as new fashions.
