- The toys & games market includes retail sales of action figures, activity toys, dolls, games, infant and baby toys, miniature models, plush toys, puzzles, ride-on model toys, and toy vehicles. All market data and forecasts are represented as consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The German toys & games retail market had total sales of \$4,473.4 million in 2021, representing a compound annual growth rate (CAGR) of 4.4% between 2017 and 2021.
- Online specialists account for the largest proportion of sales in the German toys & games retail market in 2021. Sales through this channel generated \$1,488.8 million, equivalent to 33.3% of the market's overall value.
- The growth of the German toys and games market is set to remain steady during the forecast period, mainly due to the growing prevalence of digital alternatives to toys and games among individuals across the region.
