All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The Italian beer & cider market had total revenues of \$13,072.9m in 2021, representing a compound annual growth rate (CAGR) of -2.4% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1% between 2016 and 2021, to reach a total of 2,000.3 million liters in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.4% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$16,197.7m by the end of 2026.
