- The Dutch jewelry & watches market generated total revenues of \$2,323.6 million in 2021, representing a compound annual growth rate (CAGR) of 0.2% between 2017 and 2021.
- The jewelry & watches segment was the market's most lucrative in 2021, with total revenues of \$1,206.2 million, equivalent to 51.9% of the market's overall value.
- In 2021, the market rebound to strong growth. This is attributed to economic recovery in the county and improvement in consumer confidence in the country which led to increase in consumer spending on jewelry and watches.
