Summary

Apparel Retail in Norway industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-21, and forecast to 2026). Key Highlights

- The apparel retail market includes baby clothing, toddler clothing and casual wear, essentials, formalwear, formalwear-occasion, and outerwear for men, women, boys and girls; excludes sports-specific clothing. All market data and forecasts are represented as a consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Norwegian apparel retail industry had total revenues of \$6.3 billion in 2021, representing a compound annual growth rate (CAGR) of 0.8% between 2017 and 2021.
- Clothing, footwear, and accessories specialists account for the largest proportion of sales in the Norwegian apparel retail industry in 2021, sales through this channel generated \$4.4 billion, equivalent to 69.8% of the industry's overall value.
- In 2021, due to the vaccination rollout and measures to reopen the economy, many of the restrictions imposed due to COVID-19 were lifted, thereby boosting the economic recovery and driving a resurgence of consumption. The Norwegian industry witnessed strong growth of 8.8% in 2021 as the impact of the coronavirus pandemic subsided.
