All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The Spanish beer & cider market had total revenues of \$21,231.9m in 2021, representing a compound annual growth rate (CAGR) of 1.1% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1.1% between 2016 and 2021, to reach a total of 4,235.7 million liters in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 6.1% for the five-year period 2021 2026, which is expected to drive the market to a value of \$28,591.6m by the end of 2026.
