- The Spanish toys & games retail market had total sales of \$1,384.7 million in 2021, representing a compound annual growth rate (CAGR) of 1% between 2017 and 2021.
- Other specialist retail account for the largest proportion of sales in the Spanish toys & games retail market in 2021. Sales through this channel generated \$384.3 million, equivalent to 27.8% of the market's overall value.
- The Spanish economy has undergone a period of transformation, and healthy growth in the recent past has helped to spur retail markets such as toys and games.
