- The Spanish jewelry & watches market is forecast to generate total revenues of \$3,303.9 million in 2021, representing a compound annual rate of change (CARC) of -3.6% between 2017 and 2021.
- The accessories segment was the market's most lucrative in 2021, with total revenues of \$2,198.3 million, equivalent to 66.5% of the market's overall value.
- COVID-19 had an adverse impact on the Spanish market which led to decline in market in 2020. The market recovered in 2021 due to strong demand from the local market. This is attributed to less restrictions, resumption of social events, reopening of commercial spaces, and increased consumer spending.
