All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The UK beer & cider market had total revenues of \$27,359.2m in 2021, representing a compound annual growth rate (CAGR) of -2.3% between 2016 and 2021.
- Market consumption volumes declined with a CAGR of -2.2% between 2016 and 2021, to reach a total of 4,871.2 million liters in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 6.8% for the five-year period 2021 2026, which is expected to drive the market to a value of \$37,997.1m by the end of 2026.
