Key Highlights

- The apparel retail market includes baby clothing, toddler clothing and casual wear, essentials, formalwear, formalwear-occasion, and outerwear for men, women, boys and girls; excludes sports-specific clothing. All market data and forecasts are represented as a consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Israeli apparel retail industry had total revenues of \$4.7 billion in 2021, representing a compound annual rate of change (CARC) of -0.4% between 2017 and 2021.
- Clothing, footwear, and accessories specialists account for the largest proportion of sales in the Israeli apparel retail industry in 2021, sales through this channel generated \$3.0 billion, equivalent to 64.4% of the industry's overall value.
- Online specialists now account for 17.0% of the industry's overall value. Social media usage has also been on the rise in Israel in recent years, providing a new platform through which fast fashion retailers can advertise and attract customers.
