- The Turkish savory & deli foods market had total revenues of \$253.6m in 2021, representing a compound annual growth rate (CAGR) of 17.8% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 2.7% between 2016 and 2021, to reach a total of 38.4 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 13.1% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$470.3m by the end of 2026.
