All market data and forecasts are represented as a consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The global apparel retail industry had total revenues of \$1,463.9 billion in 2021, representing a compound annual growth rate (CAGR) of 1.5% between 2017 and 2021.
- Clothing, footwear, and accessories specialists account for the largest proportion of sales in the global apparel retail industry in 2021, sales through this channel generated \$670.9 billion, equivalent to 45.8% of the industry's overall value.
- Fast fashion has proven to be a lucrative sector in the industry, with consumers expressing a desire to purchase fashionable yet inexpensive products. Europe is home to some of the biggest fast fashion companies globally, including Inditex (Spain) and H&M (Sweden).
