- The North American beer & cider market had total revenues of \$144,838.5m in 2021, representing a compound annual growth rate (CAGR) of 0.5% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 0.1% between 2016 and 2021, to reach a total of 34,030.9 million liters in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.7% for the five-year period 2021 2026, which is expected to drive the market to a value of \$191,277.0m by the end of 2026.
