- The apparel retail market includes baby clothing, toddler clothing and casual wear, essentials, formalwear, formalwear-occasion, and outerwear for men, women, boys and girls; excludes sports-specific clothing. All market data and forecasts are represented as a consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The South American apparel retail industry had total revenues of \$51.8 billion in 2021, representing a compound annual growth rate (CAGR) of 4.6% between 2017 and 2021.
- Clothing, footwear, and accessories specialists account for the largest proportion of sales in the South American apparel retail industry in 2021, sales through this channel generated \$28.2 billion, equivalent to 54.4% of the industry's overall value.
- Despite the current financial uncertainty, the industry is poised to maintain strong growth in 2022. As lockdown restrictions ease and businesses gradually resume operations, normal consumer shopping habits are likely to return and online channels will also aid revenue growth.
