Summary

Toys & Games Retail in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). Key Highlights

- The toys & games market includes retail sales of action figures, activity toys, dolls, games, infant and baby toys, miniature models, plush toys, puzzles, ride-on model toys, and toy vehicles. All market data and forecasts are represented as consumer expenditure in retailers which includes sales taxes (e.g. VAT) and figures presented are in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Scandinavian toys & games retail market had total sales of \$1,856.3 million in 2021, representing a compound annual growth rate (CAGR) of 1.6% between 2017 and 2021.
- Other specialist retail account for the largest proportion of sales in the Scandinavian toys & games retail market in 2021. Sales through this channel generated \$630.1 million, equivalent to 33.9% of the market's overall value.
- This market saw a considerable boost in 2020, as pandemic-related lockdowns saw parents increasingly purchasing toys & games to keep children entertained. However, the market experienced slow growth in 2021, since conditions returned to normal, with the reopening of schools partially responsible for slowing the growth.
