- The Jewelry, Watches and Accessories market includes gold jewelry, silver jewelry and other precious jewelry like diamonds, platinum, precious stones (sapphires, emeralds and rubies), pearls (natural and cultured) and semi-precious stones (e.g. quartz, opal, topaz, amethyst, coral etc.), fashion jewelry (non-precious jewelry), hair accessories, belts, hats, gloves, scarves, sunglasses and ties, plus watches.
- The Scandinavian jewelry & watches market generated total revenues of \$3,517.9 million in 2021, representing a compound annual growth rate (CAGR) of 0.2% between 2017 and 2021.
- The jewelry & watches segment was the market's most lucrative in 2021, with total revenues of \$2,088.8 million, equivalent to 59.4% of the market's overall value.
- In 2021, jewellery and watches demand in Scandinavia continued its recovery but fell short of pre-pandemic levels. However continued interference from restrictions to combat the spread of COVID prevented a full recovery in demand.
