- Within the apparel retail industry, China is the leading country among the BRIC nations with market revenues of \$310,053.4 million in 2021. This was followed by India, Russia and Brazil with a value of \$53,837.0, \$34,183.9, and \$21,638.5 million, respectively.
- China is expected to lead the apparel retail industry in the BRIC nations with a value of \$434,579.3 million in 2026, followed by India, Russia, Brazil with expected values of \$91,561.2, \$46,742.6 and \$26,432.7 million, respectively.
