- The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The apparel retail industry within the NAFTA countries had a total market value of \$391,703.1 million in 2021. The US was the fastest growing country, with a CAGR of 1.2% over the 2017-21 period.
- Within the apparel retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$353,104.0 million in 2021. This was followed by Canada and Mexico, with a value of \$23,311.0 and \$15,288.1 million, respectively.
- The US is expected to lead the apparel retail industry in the NAFTA bloc, with a value of \$421,441.0 million in 2026, followed by Canada and Mexico with expected values of \$30,223.8 and \$21,323.9 million, respectively.
