- Within the beer & cider industry, the US is the leading country among the NAFTA bloc, with market revenues of \$109,322.5 million in 2021. This was followed by Mexico and Canada, with a value of \$20,728.3 and \$14,787.7 million, respectively.
- The US is expected to lead the beer & cider industry in the NAFTA bloc, with a value of \$144,801.1 million in 2026, followed by Mexico and Canada with expected values of \$27,384.8 and \$19,091.1 million, respectively.
