Off-trade volume sales of bottled water see a slight decline in 2022, despite recovery due to a favourable comparison effect, as 2021 sales slumped following the strong rise seen in the first COVID-19 year in 2020. Thanks to the relatively resilient performance of the category, off-trade volume sales remain higher in 2022 than in the pre-pandemic year 2019, largely as a result of the lower level of consumption through on-trade channels than in 2019, and due to the continued rise of flavoured bot...
