Following the end of lockdown restrictions in 2021 current value sales of ice cream recovered swiftly. The year 2022 was another strong year, with impulse ice cream outperforming take-home ice cream in retail volume and current value terms as consumers made more spontaneous purchases from kiosks and shops. As a result of the increase in demand, current value sales of single portion and unpackaged ice cream recorded good growth in 2022.
