The North America brain health supplements market is expected to grow from US\$ 3,001.72 million in 2022 to US\$ 5,900.73 million by 2028; it is estimated to register a CAGR of 11.9% during 2022-2028.

Growing Prevalence of Major Depressive Disorders Boosts the North America Brain Health Supplements Market Growth

According to the National Institute of Mental Health (NIMH), ~14.8 million US adults aged 18 and above (i.e., 6.0% of the total adult population) had at least one major depressive episode with serious impairment in 2020. According to the National Center for Biotechnology Information (NCBI), there is growing evidence about the role of nutrients in mental health.

The adequate consumption of nutrients contributes to better overall health and mental health. Hence, the optimum supply of nutrients as adjunctive therapy to antidepressant treatment is essential for adequate brain functioning. The vitamins & minerals segment is subsegmented into vitamins C & E, vitamin B complex, and others.

The North America brain health supplements market, by application, is segmented into memory enhancement, attention and focus, depression and mood, sleep and recovery, anti-aging and longevity, and others. The memory enhancement segment held the largest market share in 2022.

In terms of dosage form, the North America brain health supplements market is segmented into capsules, tablets, and others . The others segment held the largest market share in 2022.

The North America brain health supplements market, by distribution channel, is segmented into supermarket and hypermarket, drug store, online, and others. The supermarket and hypermarket segment accounted for the largest market share in 2022.

Based on age category, the North America brain health supplements market is segmented into adults, children, and elderly. The adults segment held the largest market share in 2022.

The North America brain health supplements market, by country, is segmented into the US, Canada, and Mexico. The US dominated the market in 2022.
