In addition, the temporary closure of non-essential retailers contributed to decline, as the increase in sales via e-commerce was insufficient to offset the fall in store-based sales. However, jeans showed a rebound in 2021, with a double-digit increase in current value sales. There was no lockdown in most cities during the first...
