Lasers Segment is Expected to Show Better Growth during the Forecast Period

Based on surgical devices, the market is segmented into glaucoma devices, intraocular lenses, lasers, and other surgical devices. Laser eye procedure is intended to correct long-term vision problems in people. The laser can be applied to the iris or the trabecular meshwork to allow aqueous fluid to flow more effectively within the eye and drain better by the normal drainage channels within the eye. Laser vision correction has a very high success rate, and many patient's reliance on eyeglasses or contact lenses is significantly reduced. Hence, owing to the high growth opportunities, the segment is believed to witness rapid growth over the forecast period.
